

AGENCY REPORT ON APPLICATION DECISIONS MARCH 1, 2010 CYCLE

APPROVALS

Assisted Living Facilities

Atrium at Serenity Point – Garland, File # HSPA (1268)-10, was granted a Permit of Approval (POA) for the purpose of converting and renovating a 150,000 square foot resort hotel into a 75 bed Assisted Living Level II facility, to be known as Atrium at Serenity Point at 2803 Albert Pike, Hot Springs, AR (Garland County). Projected capital expenditure for this project is \$7,544,000.

Fox Ridge Estate – Saline, File # HSPA (1270)-10, was granted a POA for the purpose of converting nine (9) independent living apartments to eighteen (18) Assisted Living Level II beds at Fox Ridge of Bryant, an existing 55 bed Assisted Living Facility to create a 73 bed ALF II located at 4216 Fox Ridge Dr, Bryant, AR (Saline County). Projected capital expenditure is \$0.

Peachtree Village at Farmington – Washington, File # HSPA (1269)-10, was granted a POA for the purpose of converting an existing sixty-five (65) bed Independent Living Facility and adding five (5) beds for a total of seventy (70) beds to be an Assisted Living Level I facility called Peachtree Village at Farmington at 55 W. Rainsong, Farmington, AR (Washington County). Projected capital expenditure for this project is \$200,000.

Ridgecrest Retirement and Assisted Living – Ouachita, File # HSPA (1272)-10, was granted a POA for the purpose of constructing a new 75 bed Assisted Living Level II Facility to be called Ridgecrest Retirement and Assisted Living located at #6 Ridgecrest Drive, Camden, AR (Ouachita County). Projected capital expenditure is \$4,821,579.

Lester Dierksen Hospice – Crittenden, File # HSPA (1275)-10, was granted a POA for the purpose of providing hospice services to Crittenden County from an office in Mississippi County.

Lester Dierksen Hospice – Jackson, File # HSPA (1276)-10, was granted a POA for the purpose of providing hospice services to Jackson County from an office in Craighead County.

Washington Regional Hospice House – Washington, File # HSPA (1271)-10, was granted a POA for the purpose of constructing a 12 bed hospice facility, Washington Regional Hospice House, to be located at 412 Longview Dr, Fayetteville, AR (Washington County). Projected capital expenditure is \$3,794,553.

Assisted Living Facility

Orchard Court – Garland, File # HSPA (1275)-10, was denied a POA for the purpose of constructing a new 75 bed Assisted Living Level II Facility to be called Orchard Court, located at the corner of Pittman and Airport Rd, Hot Springs, AR (Garland County). The projected capital expenditure is \$3,920,000.
